Objectives and Investment Policy

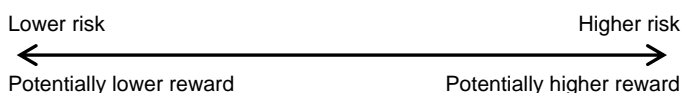
Investment Objective:

The investment objective of the Fund is to provide capital growth through diversification across major asset classes. Within each major asset class, allocations will be further diversified by factors including sector, geography and various strategies.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and alternative investment fund ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or alternative investment fund CIS, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The underlying investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options, futures and forwards.
- You can buy, exchange and sell shares in the Fund on a weekly basis on any business day in Dublin.
- Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 30 June and 31 December in each year (the "Distribution Date"), and such dividends will be paid on or before the 14th Business Day following the Distribution Date.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

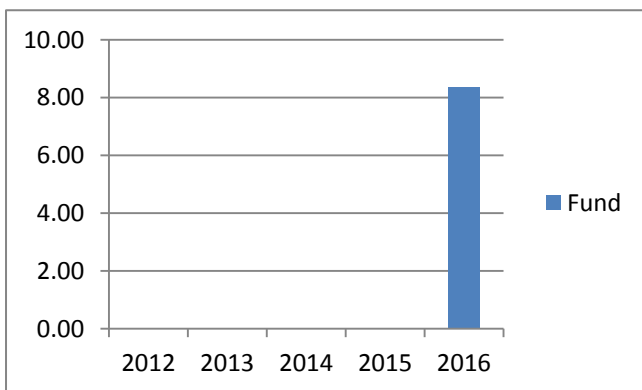

Charges
