Objectives and Investment Policy

Investment Objective:

To seek total returns with an emphasis on long term growth but with the potential for some degree of income generation.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and non-UCITS collective investment schemes ("CIS"). The CIS that the Fund may invest in will be authorised as UCITS or non-UCITS CIS, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The underlying investment schemes will invest in principally equity securities and fixed income on a global basis. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes.

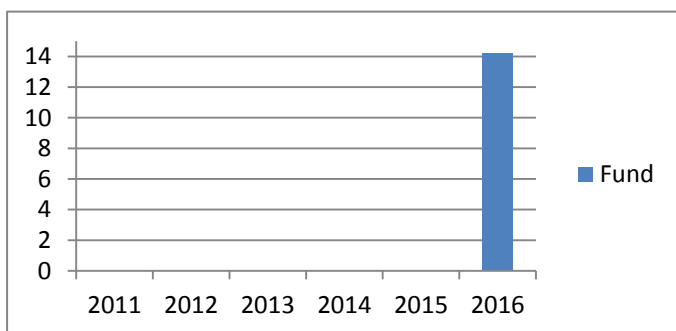
