Objectives and Investment Policy

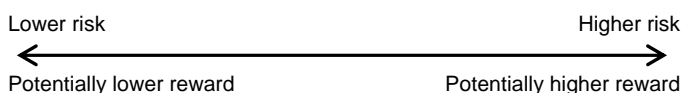
Investment Objective:

The investment objective of the Fund is to seek to achieve a lower volatility than equity markets over the long term whilst seeking to achieve positive returns. This will be achieved by predominantly taking positions in a variety of CIS that employ specific investment strategies.

Investment Policy:

The Fund will invest in a diversified portfolio of authorised open-ended UCITS and/or Exchange Traded Funds and alternative investment funds (together "CIS"). Such CIS will employ specific investment strategies, when combined together, will seek to have a lower volatility than equity markets and will seek to have an uncorrelated return profile to equity markets. The CIS that the Fund may invest in will be authorised as UCITS or alternative investment funds, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man. The CIS will invest in principally equity securities and fixed income on a global basis. The Fund may also invest in a CIS with exposure to other asset classes: money market instruments, property, private equity, absolute return funds, managed futures and hedge funds. The asset allocation strategy may be altered by the Investment Manager on a monthly basis or more frequently to take into account changes in the expected risk and correlations of the underlying asset classes. The Fund may also invest directly in assets for short term liquidity, pending investments or defensive purposes i.e. direct cash, deposits, money market instruments.

- This class does not intend to pay a dividend. Any income generated by the Fund is reinvested to grow the value of your investment.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

Charges
