Objectives and Investment Policy

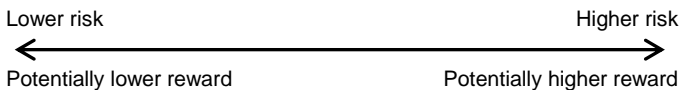
Investment Objective:

To provide long term capital growth spreading the risk through geographical and sector diversification whilst predominantly taking long only investment positions in mostly UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets

Investment Policy:

The Fund will seek to achieve its investment objective by investing in Exchange-Traded Funds ("ETFs"). The Fund may also, to a lesser extent invest in Collective Investment Schemes ("CIS"). The ETFs and CIS will provide exposure predominantly to UK, European and US equity markets with some exposure to Japan, the Far East and emerging markets. The CIS that the Fund may invest in will be authorised as UCITS or non-UCITS CIS, consist of regulated collective investment schemes which may be domiciled in a member state of the EEA, the U.S., Jersey, Guernsey or the Isle of Man.

Other Information:

- The Fund may use FDIs for efficient portfolio management and currency hedging purposes. Such techniques and instruments include options and forwards.
- You can buy, exchange and sell shares in the Fund on a daily basis on any business day in Dublin.
- Subject to net income being available for distribution, the Directors intend to declare dividends on the distribution date, which shall usually be 30 June and 31 December in each year (the "Distribution Date"), and such dividends will be paid on or before the 14th Business Day following the Distribution Date.
- The Fund may not be appropriate for investors who plan to withdraw their money in 2-3 years.

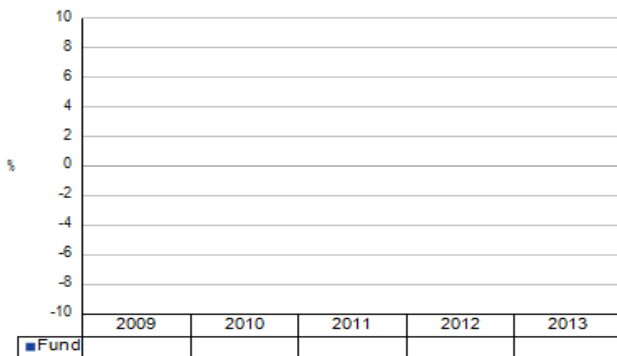

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
