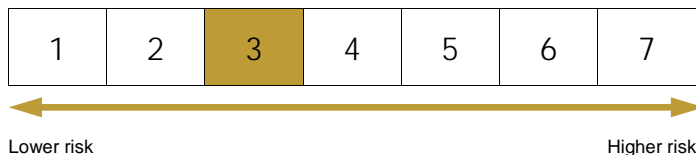

### WHAT IS THIS PRODUCT?

TYPE:	This Product is an Alternative Investment Fund
OBJECTIVES:	The objective of The Managed Fund is to seek to achieve capital appreciation. The objective will be achieved by investing in a range of assets which will be primarily equities, investment grade bonds, property and cash. Davy Asset Management as Investment Manager will vary the proportion of The Managed Fund invested in each asset class in line with its views on the relative growth potential of each sector and consistent with its policy of maintaining a diversified portfolio.
INTENDED RETAIL INVESTOR:	The Product is targeted only at clients of Davy Asset Management. The investor's objective for this investment should be aligned with that of the Product as outlined above.

### WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The risk indicator assumes you keep the product for 1 year. The actual risk can vary significantly if you cash in at an early stage and you may get back less. ### COSTS OVER TIME
