# 2024 Irish M&A Market

424 Deals in 2024 vs. 405 in 2023, representing a c.5% increase in activity levels. Disclosed Deal Value of c.€13bn, a reduction of c.60.9% on a headline basis, but on an adjusted basis the underlying reduction was c.9.5%



# 2024 Irish M&A Market Review:

2024 saw continued consolidation in Insurance broking, Logistics and a step-up in activity within Professional Services (Accounting, Legal)

#### Overview of global transaction activity

Irish M&A materially outperformed Global M&A, as measured by Deal Volume, in 2023 and this continued into 2024, but as the year closed global M&A activity picked up with improved guarter-on-guarter performance versus 2023.

#### **Overview of Irish transaction activity**

2024 was another strong year for Irish M&A activity and this was very noticeable as we moved through each quarter. While our preferred measure of activity, namely Deal Volume showed an increase of c.5% on 2023 to give a total Deal Volume of 424 deals it is important to remember that 2023 was also a particularly strong year and in that context a further increase in Deal Volume is welcome. For Irish M&A we are now seeing an average annual Deal Volume of c.400 deals which as pointed out in previous quarterly reviews is a materially higher level than those experienced up to and including 2020 (2016 – 2020 inclusive average annual Deal Volume is c.270+). There are a number of drivers of this activity, many of which we are familiar with and include:

- Privately owned (Family or Entrepreneur) companies now increasingly comfortable with using M&A as a growth strategy;
- Irish plcs continuing to be acquisitive overseas;
- Private Equity, both through new initial acquisitions, or indirectly through supporting investee companies to scale through acquisition, with the latter being more noticeable in 2024 and in 2023: and
- Consolidation of certain sectors with 2024 seeing significant activity in Professional Services, particularly in Accounting & Assurance but now beginning to become more prevalent in Legal Services also. Insurance broking and logistics continued with subsequent rounds of consolidation during the year.

#### Top 10 Transactions

The Top 10 transactions of 2024 as shown on Page 8 occurred mainly in the second and third guarters with these including Flutter's acquisition of Sanitech for c.€2.3bn, Let's Get Checked's acquisition of US based company Truepill for c.€0.5bn and Valeo Foods' acquisition of IDC for c.€0.45bn. The Top 10 transactions included a number involving Irish companies being acquired including EQT's acquisition of AMCS for a reported c.€2bn, Turner's acquisition of Dornan Engineering for c.€0.4bn, CIMSA's acquisition of Mannok for c.€0.33bn and R&S Group's acquisition of Kyte Powertech for c.€0.25bn. The Top 10 transactions also included one In-Market transaction with Kerry Co-op agreeing to acquire Kerry Group plc's Dairy Division for c.€0.5bn.

# 2024 Irish M&A Market Review:

Despite reduction in Disclosed Deal Value of c.9.5% (adjusted), Median Deal Value increased c.4.4% versus 2023 to c.€45m

#### **Deal Value**

Deal values were disclosed for only 16% of Irish M&A deals in 2024 versus 21% in 2023 with disclosed Deal Value for 2024 being c.€13.0bn versus c.€33bn in 2023. This represented a reduction of c.61% versus 2023, essentially due to the outsized impact of the Smurfit Westrock merger in Q3'23 which contributed c.€19bn to 2023 Deal Value. By contrast the largest transaction in 2024 was the aforementioned Flutter acquisition of Snaitech for c.€2.3bn. Adjusting for the outsized impact of Smurfit Westrock shows disclosed Deal Value is down c.9.5% on 2023, but within this the Median disclosed deal value showed a modest increase of c.4.4% to c.€45m.

#### Activity By Sector

Tech & Telecoms continued to be the most active sector in the Irish M&A market in 2024 with 87 deals (accounting for c.20% of total Deal Volume), but it was marginally down on 2023 levels. Some of the notable transactions in Tech & Telecoms included EQT's acquisition of AMCS for c.€2bn, Starwood's investment in Echelon at a c.€1.6bn deal value, Phoenix Tower's c.€1bn acquisition of Cellnex and EPAM acquiring First Derivative for c.€275m. Industrials, whilst down on 2023 levels was the second most active sector with 56 deals (accounting for c.13% of total Deal Volume) with notable transactions including acquisitions by Kingspan plc (Nordic Waterproofing, Mercor) and Grafton's strategic acquisition of Salvador Escoda, a Spanish market entry and platform business, for c.€132m as well as acquisitions of Irish companies by overseas acquirers including Elgin Energy, Kyte Powertech and Davenham Switchgear. Business Services and Leisure & Travel were the two sectors that showed notable increased activity in 2024 versus 2023 as measured by deal volume. Business Services was driven by considerable activity from a number of Irish companies including DCC, with eight acquisitions during the year, and private equity backed companies such as Net Zero, Bellew Electrical and Virginia Transport completing a number of In-Market transactions with acquisitions of Irish based companies. Within Business Services there was activity in property management and advisory services with acquisitions of companies such as Christies Property Management, O'Connor Shannon Estate Agents and OCS Auctioneers. Logistics was also an active segment with Irish acquirers including Primeline Logistics (acquisition of Global Cargo Solutions), Virginia Transport (acquisition of Allmed Logistics) and Masterlink (acquisition of Securispeed) and overseas acquirers of BC Express, Air Ocean and Sanford Freight. M&A involving companies providing renewable energy, energy efficiency and related services was significant during 2024 including the aforementioned acquisitions by DCC plc and Net Zero but there were also transactions involving Irish companies Bluebird Renewables and JFW Renewables.

# 2024 Irish M&A Market Review:

In-Market, domestic transactions accounted for c.30% of total Deal Volume in 2024 following a strong year in 2023 also

#### Activity By Sector (contd)

Leisure & Travel saw a number of high-profile transactions during 2024 including two sizable transactions by Flutter (Snaitech and NSX Services), the acquisition of The Shelbourne Hotel for a reported c.€310m and Dalata's acquisition of the Radisson Airport Hotel for a reported c.€83m. However, the significant increase in deal volume was driven by a large number of single hotel (property and operating activities) acquisitions, several acquisitions of pub businesses in addition to transactions involving restaurant groups such as McDonald's franchises and Freshly Chopped as well as more novel Leisure & Travel businesses such as Hostels (Jacobs's Inns and Sleepzone) and league of Ireland football clubs (Dundalk and Cobh-Ramblers).

#### Deal Type

Domestic **In-Market** Irish deals represented the largest share of transaction volume by deal type in 2024 at c.30%. This has been rising steadily from Q4'23 throughout 2024 and as pointed out much of it is driven by privately owned (Family or entrepreneur) Irish companies becoming increasingly active in M&A and private equity owned businesses executing on buy and build strategies in fragmented sectors of the domestic economy. Several of the deals they were involved in have been mentioned above and are all noted in the Appendix. Irish **Acquisitions of Foreign Companies** was second in market share for 2024 at 23% by deal type, with **UK and Rest of World Acquirers of Irish Companies** the joint third most active deal type with each accounting for c.14%. We have seen particularly in Q3'24 a diverse geographic spread of Irish company buyers including buyers from Japan, Switzerland, Turkey, Netherlands and Belgium.

**Private Equity** deal volumes represented c.9% share of transaction volumes in 2024 with 39 deals. This was well down on 2022 and 2023 levels when there were 61 and 60 deals respectively. Much of the private equity activity in 2024 was indirectly through portfolio company M&A. A number of dedicated Irish funds are currently raising new funds, for some of the sponsors involved their third such funds, and this should be noticeable in 2025 with further activity from these sponsors.

#### <u>Outlook</u>

Moving into 2025 we are fortunate that the Irish macro picture is strong (although some headwinds have been recently flagged). Confidence levels across Irish companies and their capital providers are strong and we should see further positive impact from further reductions in the cost of capital in 2025. New dedicated Ireland focused private equity funds will support activity with further capital deployment and as has been particularly evident in 2024 private equity owned portfolio companies are active consolidators in a number of fragmented domestic economy sectors. We should also see continued consolidation activity in certain services sectors, including Professional Services in 2025, all of which should help sustain the current level of Irish M&A activity in the year ahead.



Enterprise Value (€billion)










# 2024 M&A Deal Volume

c.5% increase on 2023 Deal Volume giving a fourth successive year of c.400 deals

- Increase of c.5% on 2023 deal volume, which whilst modest, should be considered in context of 2023 also being a very active year for Irish M&A
- Full year 2024 deal volume is c.159% of long-term average annual deal volume (267 deals)
- 2024 has seen the second level of activity since our review commenced in 2006, with only 2022, with a deal volume of 446, showing a higher level of deal volume
- More importantly we are now showing a fourth successive year of deal volumes of c.400, with an average deal volume from 2021 to 2024 of 416 deals











# Q4'24 Irish M&A Market Review:

Leisure & Travel and Business Services sectors showed meaningful activity during Q4'24. Reduction of c.9.2% in Median Deal Value vs. Q3'24 but at €50m remains significantly ahead of quarterly level since Q1'21

#### Overview of global transaction activity

Q4'24 Global M&A activity reported a c.22.5% decrease in deal value to c.€368bn versus c.€475bn reported in Q4'23. In terms of deal volume there was a c.7% reduction in Q4'24 to 6,277 deals from 6,741 in Q4'23.

The marked theme of US large or mega cap transactions which we have seen in the first 9 months of 2024 continued into Q4 – six of the ten largest M&A transactions during Q4'24 all involved US companies. These included BlackRock's acquisition of HPS investment Partners for c.€13.3bn, Omnicom Group's c.€13.1bn acquisition of The Interpublic Group and Arthur J. Gallagher & Co's c.€12.7bn acquisition of Assured Partners.

The largest deal reported in Europe was the British multinational insurance company Aviva's c.€4.3bn acquisition of its smaller rival, Direct Line a very significant transaction in the Insurance sector and would give the combined company a more than 20% share of both home and motor insurance in the UK.

#### Overview of Irish transaction activity

Q4'24 saw Irish companies involved in a total of 106 transactions with the level of disclosed deal value at c.€1.5bn. At 106 deals Q4'24 was broadly in line with the average of the first three quarters of 2024.

#### **Top 10 Transactions**

The largest transaction by deal value in Q4'24 was Kerry Group plc's disposal of its Dairy Division to Kerry Co-op for a reported c. $\leq$ 500m. Other notable transactions included Kingspan plc's acquisition of a c.27% stake in Nordic Waterproofing for a reported c. $\leq$ 167m (based on a reported deal value of c. $\leq$ 421m), the c. $\leq$ 275m acquisition of First Derivative by EPAM, 3i's acquisition of a significant majority interest in WaterWipes for c. $\leq$ 145m and Grafton Group plc's strategic, and Spanish market entry, acquisition of Salvador Escoda SA for c. $\leq$ 132m.

#### Deal Value

Disclosed deal value during Q4'24 was c.€1.5bn, a significant reduction on Q3'24 at c.€6.9bn. However, as we pointed out in our Q3'24 review there were a significant number of sizable deals (10 in excess of €100m) including Flutter's acquisition of Snaitech for c.€2.3bn and EQT's acquisition of AMCS for a reported c.€2bn.

#### Activity By Sector

The most active sectors during Q4'24 were **Tech & Telecoms** with 22 transactions followed by **Leisure & Travel** and **Business Services** with 14 and 13 transactions respectively. **Tech & Telecoms** saw two very significant transactions with EPAM acquiring First Derivative and Denmark's Conscia acquiring PlanNet21 Communications. Serial acquirer Integrity360 was also active during the quarter with the acquisition of Adsigo and private equity backed Luzern Solutions acquired Tambo Marketplaces.

In-Market transactions accounted for the largest share by Deal Type. Financial Investor, Private Equity activity was more pronounced at the portfolio company level

#### Activity By Sector (contd)

Leisure & Travel saw a number of hotel acquisitions the largest of which was Dalata plc's acquisition of the Radisson Blue Airport Hotel for a reported c.€83m and two acquisitions by the Neville Hotel Group. Business Services was notable for continued acquisitions by DCC plc with four acquisitions during the quarter across both its Energy and Healthcare divisions and a further acquisition by private equity backed Bellew Electrical when it acquired Cable & Accessories, one of Northern Ireland's largest independent electrical wholesalers. Professional & Technical had four transactions during the quarter involving acquisitions or mergers of legal practices. There has without doubt been more transactions involving accountancy firms to date but in both Q3'24 and Q4'24 there was a notable increase in those involving legal practices, including in Q4'24 the merger of Byrne Wallace and LK Shields.

#### Deal Type

By Transaction type **In-Market** deals accounted for the highest number at 30 with such deals including the aforementioned Kerry Group plc's Dairy Division, Dalata's acquisition of the Radisson Blue Airport Hotel, the merger of Byrne Wallace and LK Shields as well as DCC Healthcare's acquisition of Iskus Health and the notable acquisition of Tipperary Co-op by Arrabawn Co-op. There were 29 **Irish Acquisitions of Foreign Companies** and notwithstanding increasing overseas acquisitions by privately owned Irish companies this category of deal continues to reflect more plc activity – during Q4'24 each of CRH, DCC and Kingspan announced 3 overseas acquisitions with 2 announced by Origin. However, on the private company side, Kepak acquired Summit Foods in the UK during the quarter and Keywords Studios continues to be acquisitive under its new private equity owners with the acquisition of US based Certain Affinity.

There were a number of notable **Financial Investor, Private Equity** transactions during Q4'24 including 3i's c.€145m majority investment in WaterWipes, Oaktree's investment in LED Lighting & Electrical Distribution Group, Five Arrows Principal Investment's acquisition of a significant minority interest in Schivo and Melior Equity Partners' majority acquisition of Northern Ireland based Blair Caravans. In addition, private equity investee companies continued to be acquisitive during the period including Bellew Electrical (Waterland), Luzern Solutions (Cardinal), Integrity360 (August Equity), Enva (I Squared Capital) and Keyword Studios (EQT).









# Q4'24 M&A Deal Values

Only 14% of deals disclosed deal values in Q4'24 representing c.€1.5bn of deal value

- Deal values were disclosed for 14% (15/106) of Irish M&A deals in Q4'24 vs. 21% (20/95) deal value disclosure in Q4'23

- The largest transaction by deal value in Q4'24 was Kerry Group plc's disposal of its Dairy Division to Kerry Co-op for a reported c.€500m



- By disclosed deal value Food & Agri (€0.6bn), Industrials (€0.4bn), Tech & Telecoms (€0.3bn) and Consumer (€0.1bn) represented the largest sectors
- Food & Agri's total disclosed deal value was essentially represented by Kerry Co-Op's c.€500m acquisition of Kerry Group plc's Dairy Division
- **Financial Services** Industrials transactions included Kingspan's c.27% stake acquisition in Nordic Waterproofing for a reported c.€167m (based on a reported deal value of c.€421m) and its acquisition of Mercor SA for a reported c.€97m
- The Tech & Telecoms sector had one notable transaction, namely EPAM's acquisition of First Derivative for c.€275m
- Consumer transactions included 3i Group's acquisition of a significant majority stake in WaterWipes for c.€145m








# Q4'24 M&A Deal Volume by Deal Type

In-market Irish deals represented the largest share of transactions by deal type in Q4'24, consistent with the prior three quarters of 2024







# Q4'24 Median Deal Value

Q4'24 Median Irish deal value of €50.0m – c.9% below Q3'24, but c.43% above median deal value level since Q1'21 (€35.0m)

- Median deal value in Q4'24 was c.€50.0m, a c.9% decrease from Q3'24 (though latter benefitted from a higher level of deal value disclosure (18%) and a large number of higher value transactions – Dornan, Mannok, Kyte Powertech and several others)
- Based on an illustrative EBITDA multiple of 8x, this would imply that the median EBITDA for M&A transacted companies in the Irish market during Q4'24 was c.€6.3m
