Summary of Objective¹

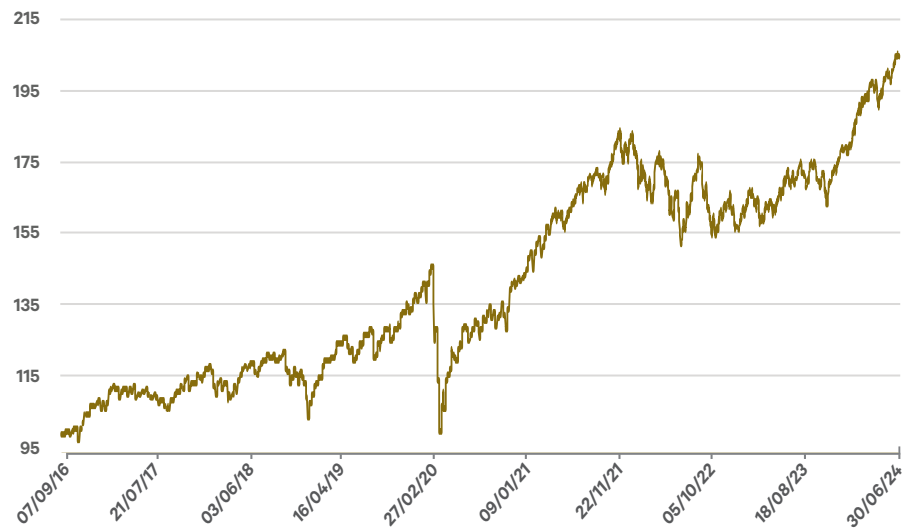

Figure 2: Asset Allocation

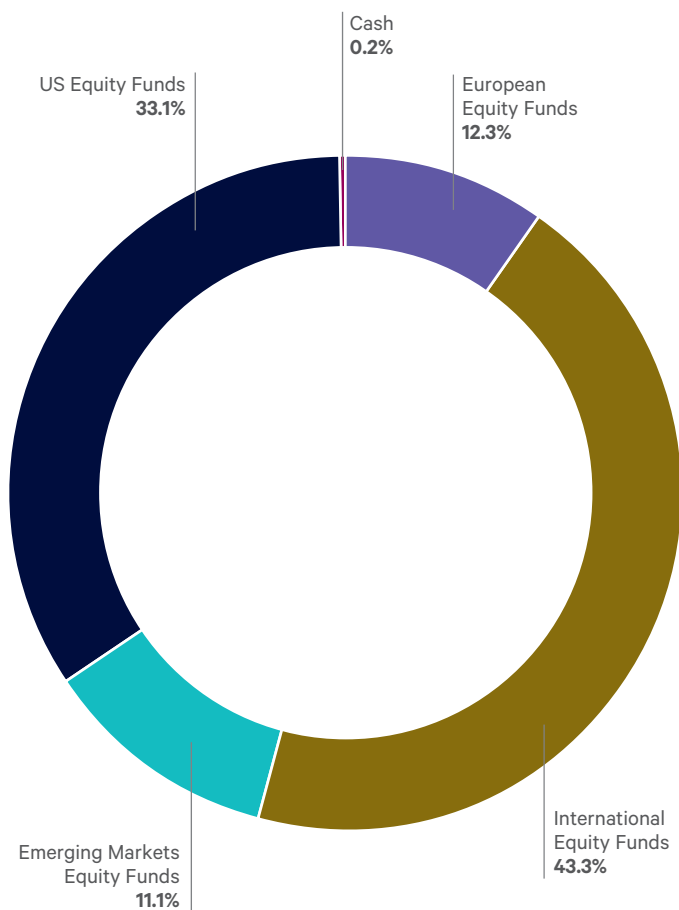
