### Summary of DGFF Objective<sup>1</sup>

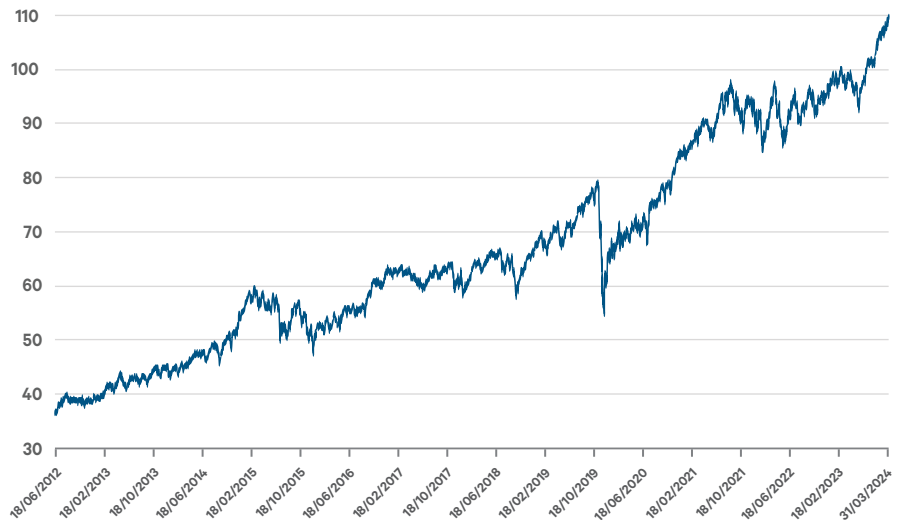

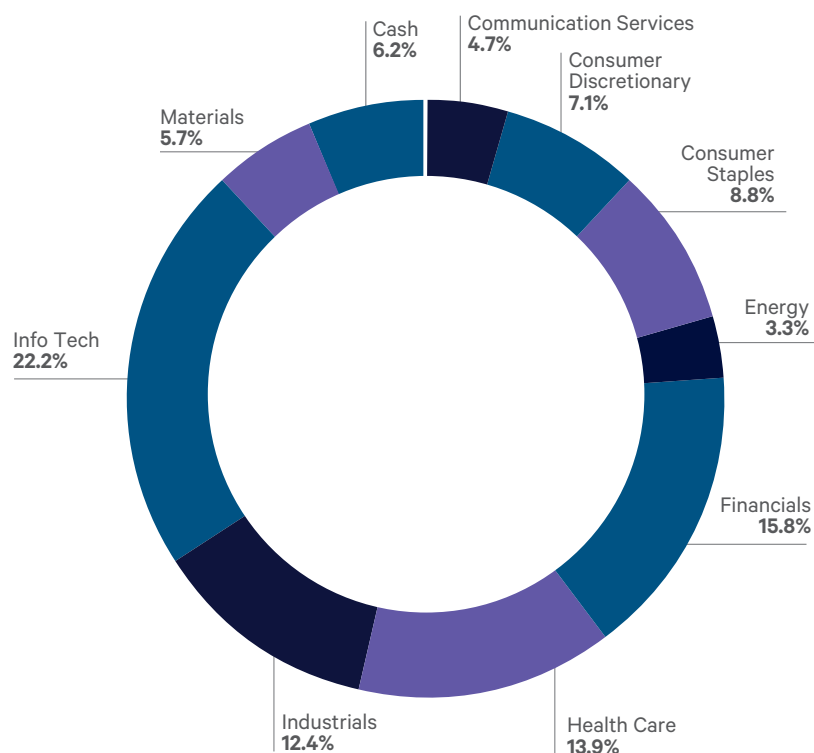
