Summary of Objective¹

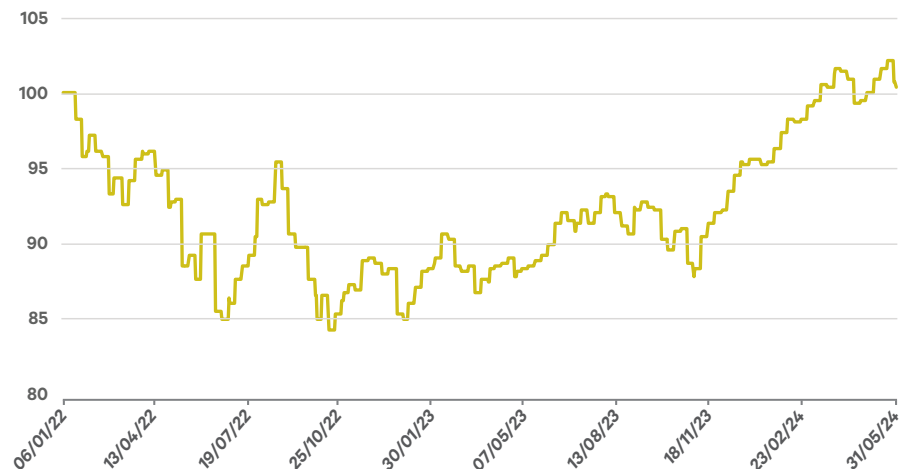

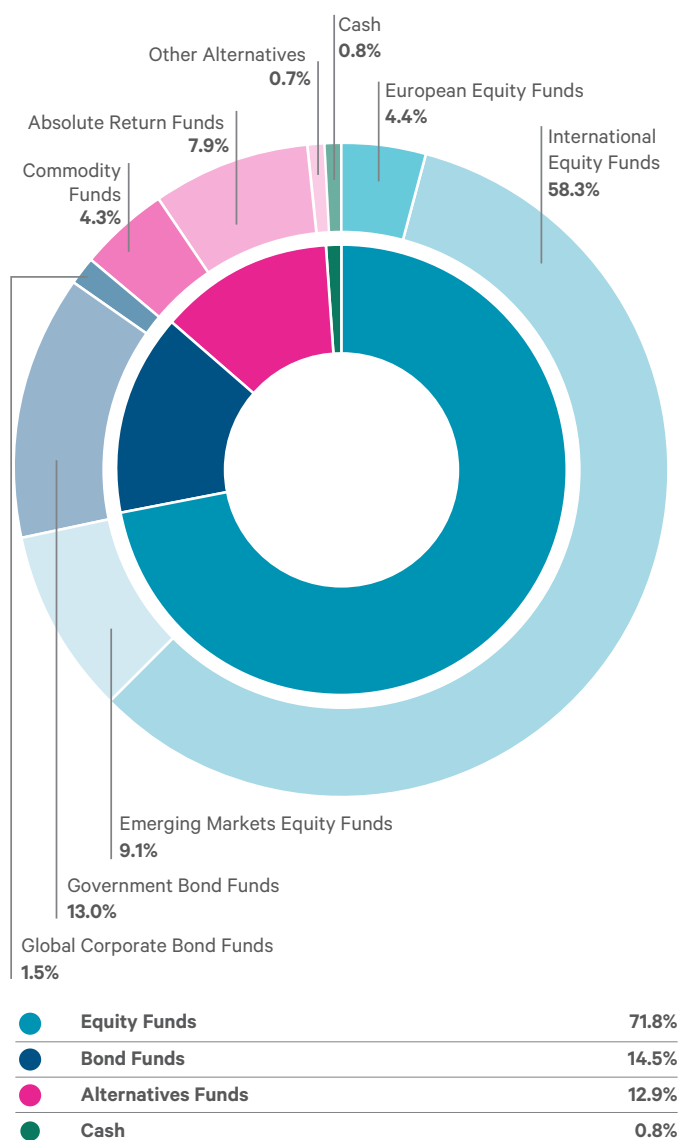
