Summary of Objective¹

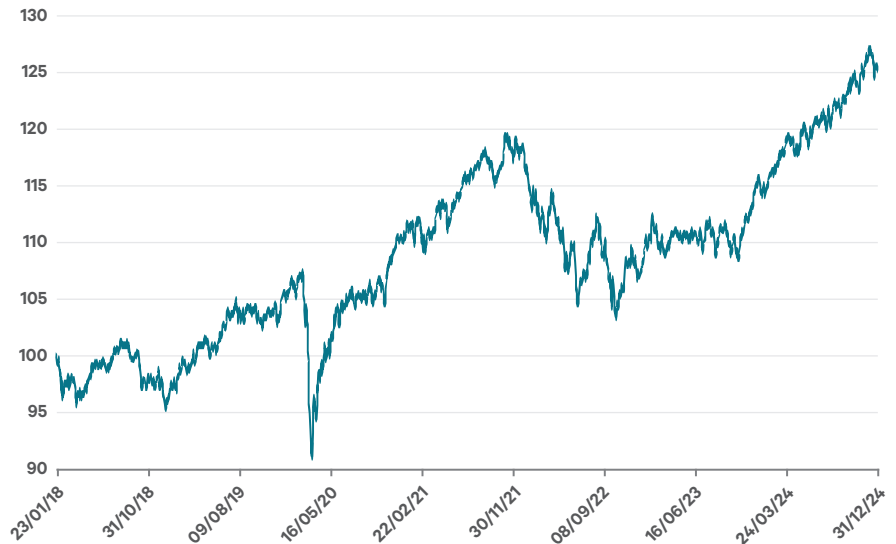
The objective of the Davy UK GPS Defensive Growth Fund is to achieve steady capital appreciation by investing in a diversified portfolio of both UK and overseas investments.

Figure 2: Asset Allocation

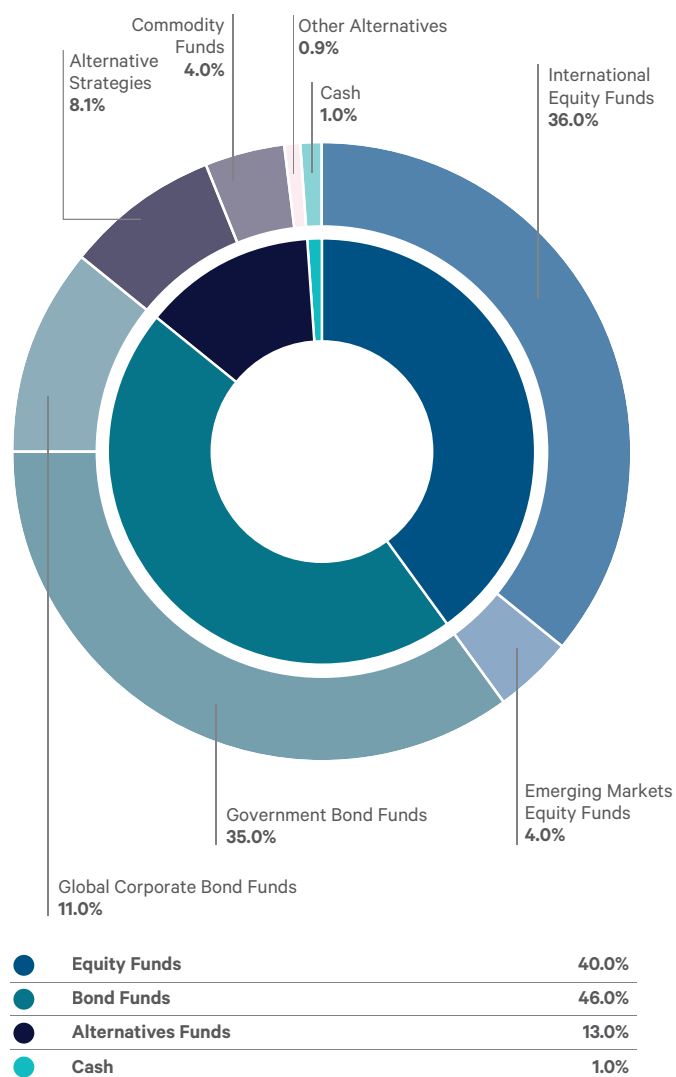
